- B. Honorable Gary Cunha discussed tabling items until next meeting, keep on agenda for next month, dos and don'ts and he found nothing wrong with tabling them. Mayor Jo Farar talked about not having pressure for a fire and do we need a fire hydrant. GWSC President Bob Mackie thought we had enough power and Water Operator Brandon Berry was unaware of any issues. - E. Approval of November 2024 Financials Pam Gresham made the motion to accept financials as presented with Jo Farar seconding, Motion passed unanimously.
- F. 2024 2025 BUDGET Jo Farar made the motion to accept the budget as presented with Pam Gresham seconding. Motion passed with exception of Doyle Parks opposing as he was not given sufficient time to look over.
- G. CHANGING COMPANY ADDRESS Doyle Parksmade motion to change GWSC business address to 145 Satin Road, Chilton, Texas 76632 with Bobby Farney seconding. Motion passed unanimously.
- H. GWSC USDA loan USDA loan was originally \$473,000 4.35% interest rate. The interest is more than the principal at this rate. Doyle Parks made the motion to place on agenda each month and possibly pay something to get it down. Jo Farar seconded with motion passing unanimously.

- L. Discussion was held in regard to investments GWSC has as of now which are Edward Jones and Government Money Market. Doyle Parks asked Cindy Bunch to look into these and report back at the January meeting.
